Dear Senators Kaine and Young and Representatives Wild, Kiggans, Dingell, and Carter:

On behalf of the American College of Osteopathic Family Physicians (ACOFP), I write to express support for S.3679/H.R. 7153, the *Dr. Lorna Breen Health Care Provider Protection Reauthorization Act*, which would reauthorize the *Dr. Lorna Breen Health Care Provider Protection Act* to reduce and prevent suicide, burnout, and mental and behavioral health conditions among health care professionals.

ACOFP is the professional organization representing more than 26,000 practicing osteopathic family physicians, residents, and students throughout the United States who are deeply committed to advancing our nation's health care system by improving health care delivery and outcomes and ensuring that patients have access to high-quality care. We believe that ensuring access to primary care physicians results in patients with better outcomes and a more efficient health care system.

The *Dr. Lorna Breen Health Care Provider Protection Reauthorization Act* would reauthorize grant funding for health care organizations and professional associations to support employee education on strategies to reduce burnout, peer-support programming, and mental and behavioral health treatment. It would also reauthorize grant funding for health profession schools to provide training to health care workers on strategies to prevent suicide, burnout, mental health conditions, and substance use disorders (SUDs). Further, the bill would reauthorize funding to continue a national evidence-based education and awareness campaign to reduce health care worker burnout and expand the campaign beyond its current scope.

ACOFP supports federal programs that address physician burnout and promote physician wellness to establish a culture of wellbeing among the physician community. Specifically, we support additional funding for mental and behavioral health training for health care professionals and grants to promote mental health and resiliency among health care providers.

Thank you for your leadership in advancing policies that promote physician wellness. We look forward to working with you to advance this important legislation.
