# **Longitudinal Osteopathic Recognition Curriculum**

# **Rotation-Specific Residency Curriculum**

#### **Problem Identification**

While Osteopathic Manipulative Treatment (OMT) has been shown to improve outcomes compared to standard of care alone<sup>1</sup>, osteopathic residents feel uneasy incorporating it into patient care. While residents are aware of the benefits of OMT<sup>2,5</sup>, they report barriers such as a lack of exposure for how OMT can be integrated into a family medicine clinic encounter, a lack of knowledge regarding billing/coding, and inadequate time available during clinic hours<sup>3</sup>. Residents also identify a lack of preceptor knowledge regarding OMT and its indications<sup>3,4</sup>. If residents were trained to incorporate OMT into patient care encounters, thereby improving their own self-efficacy into the primary care setting, then they would be more likely to perform OMT as attendings.

#### **Needs Assessment**

#### **General Needs**

While all osteopathic medical students spend two years learning basic techniques in OMM lab, not all students have a dedicated OMM rotation during their 3rd or 4th year. These later years they learn how to incorporate their basic techniques into clinical applications, preventing them from losing interest in maintaining their OMT skills. Residency training, likewise offers opportunities to consolidate their OMT skills into patient care applications, however, many residency programs lack faculty experienced in teaching and delivering OMT care and advancing resident education.

#### Learners' Needs

Within the residency program, we plan to supplement resident educational experiences with a rotation-specific, independent learning curriculum. This will supplement our monthly OMM didactic curriculum which includes hands-on, small group opportunities.

The faculty contribute to resident growth and learning, while also continuing to expand their own knowledge and skills. Providing an independent learning osteopathic education tool will serve to better equip faculty to provide osteopathic care to their patients and to support resident education and growth.

#### Goal

The goal of this curriculum is to improve OMM knowledge and skills by completing an integrated, rotation specific osteopathic independent study curriculum throughout the residency program. Towards this end, the standardized curriculum will incorporate the ACOFP's numerous digital and print media, along with seminal articles and texts, to deliver a consistent, high-quality resident education supporting Osteopathic Principles and Practices.
